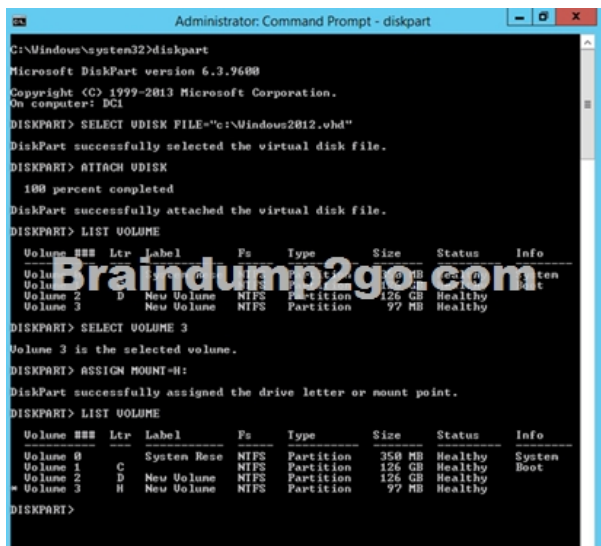

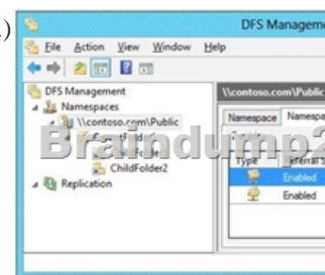

Connection request policies can be configured to designate which RADIUS servers are used for RADIUS accounting. * With connection request policies, you can use NPS as a RADIUS server or as a RADIUS proxy, based on factors such as the following: The time of day and day of the week The realm name in the connection request The type of connection being requested The IP address of the RADIUS client

Ntdsutil and Dismgmt are command-line tools that are built into Windows Server 2008 and Windows Server 2008 R2. / partition management create nc %s1 %s2 Creates the application directory partition with distinguished name %s1, on the Active Directory domain controller or AD LDS instance with full DNS name %s2. If you specify "NULL" for %s2, this command uses the currently connected Active Directory domain controller. Use this command only with AD DS. For AD LDS, use create nc %s1 %s2 %s3. Note: * An application directory partition is a directory partition that is replicated only to specific domain controllers. A domain controller that participates in the replication of a particular application directory partition hosts a replica of that partition.

Using security filtering, you can specify that only certain security principals within a container where the GPO is linked apply the GPO. Security group filtering determines whether the GPO as a whole applies to groups, users, or computers; it cannot be used selectively on different settings within a GPO.
